Lynn reported that she continues to work with the following schools.

Egg Harbor Township: Alder Avenue School – Project Wet Water Festival - May

**Hamilton Township – Mays Landing:** Fred and Lynn helped to judged St. Vincent DePaul's Science Fair in March. ### **River Councilor Reports for each Municipality**

**Buena Vista Twp.:** (Julie Akers): For the past several years the township committee has talked of installing a small sewage treatment plant. The Pinelands Commission funded a study for this project. The Township Committee has since shelved this project and no further action will take place at this time.

Egg Harbor Twp.: (David Brown): The Duke of Fluke will be put in the water today.

**Estell Manor City: (Jim Owen):** The Stevens Creek Great Egg Harbor River Council sign was damaged. It has been repaired and is due to be put back up.

**GEHWA:** (**Dick Colby**): The ACUA sponsors community clean ups. Atlantic County Parks will have a new head. Dick participated in a forum that was held regarding water management of the Kirkwood Cohansey. The BL England power plant burns coal and oil to produce electricity and would like to convert the plant to natural gas. Dick asked if the drought is having an impact on the vernal ponds and frog populations?

**GEHWA:** (Clay Emerson – Alt.): Gave a presentation at Stockton on stormwater management.

**Hamilton Twp.:** (Bill Christman): The retention ponds at the Hamilton Mall are dry. The water was pumped out. Approx. 10,000 fish were removed with a 50 ft. bag seine and the fish were transferred to Lake Lenape. Princeton Hydro did the work. They had fish removal and stocking permits from the state.

**Hammonton:** (Chris Jage – Alt.): On March 3<sup>rd</sup> Hammonton City held its annual Hammonton Lake cleanup that included cleanup of the town. Hammonton City is working to have the whole town certified by the National Wildlife Federation as a Backyard Habitat.

**Somers Point:** (**Greg Gregory**): The owner of Bay Breeze Marina would like an Osprey platform installed near his home. He is willing to pay costs.

**Upper Twp.:** (Steve Eisenhauer - Alt.): In June students from Middle Township MS will take part in a variety of programs at Beesley Point and Somers Point (Kennedy Park).

**Winslow:** (Clark Sprigman): The Environmental Commission collected old electronics from residents. It was a very successful program. Many residents turned in old electronics.

#### **Other New Business:**

None

#### Administrator's Report (Fred Akers):

- **1. CoCoRaHS Recogonition**: Fred and Lynn received recognition from the NJ State Climatologist's office for their contribution in reporting precipitation to the CoCoRaHS organization in 2011.
- **2. PWSRs Letter to President Obama and VP Biden:** A letter to the president and vice-president and congress will be sent asking for an additional \$446,000 to support the PWSRs.
- **3. Great Egg Designation History Presentation:** Fred presented "National Wild and Scenic Rivers in the Pinelands National Reserve" at the Pinelands Short Course in March. Documents are included in the RCs packets regarding this program.
- **4.** New Natural Lands Preservation Report: Potential land acquisitions: Lenape Farms (Burns 2795 acres and Reardon 2139 acres) 4934 acres. Also, 400 acres of Atlantic Blueberry fields will be donated to the state of NJ. Winslow Twp will transfer some lots to NJ Fish and Game (may include an old landfill).
- **5. Hamilton Mall Basin Repair:** The Mall basins have been drained and there are plans to repair them. The fish were relocated.
- **6. Great Egg Harbor River Fisheries Study:** In 98-99 the NPS paid for a fish study. River Herring (Alewife and Blueback) are currently being studied for listing under the Endangered Species Act. The Atlantic Sturgeon has been listed as endangered. American Eel are also under consideration. New 2012 size limits and fish advisory included in RC packets.
- 7: River Herring/Menhaden Rescue Update: Letters that have been sent are included in RC packets.
