A copy of the notice was posted on the bulletin board of the Fox Nature Center, Atlantic County Library in Mays Landing and the GEHWA website.

Approval of Minutes: Bill Christman made a motion to approve the minutes of the June 20, 2012 meeting. Julie Akers seconded the motion. Motion carried.

Education & Outreach Coordinator Report (Lynn Maun)

Events and Meetings: GEHWA sponsored and/or supported the following events.

Atlantic County Bike Trail Cleanup: GEHWA partnered with Atlantic County Parks to clean up storm debris from alongside the Atlantic County Bike Trail. AC personnel were unable to mow the area because of woody debris along the trail

GEHWA Annual Picnic: The annual picnic and campfire was held on Tuesday, July 24, 2012 at Lake Lenape, Mays Landing. The location of the event was changed from Weymouth Furnace due to storm damage there from the derecho. There were a total of nine people for dinner. Almost everyone left following dinner due to threatening weather. The participants were warned by the Park Ranger of a thunderstorm in the area. There were 2 late arrivals that missed out on most of the food.

Upcoming Events:

Richard Hoch Show: Lynn will be on the Richard Hoch radio show on Thursday, August 16th at 4:00PM. The Topic: "Saving Water Indoors and Outdoors – Beautiful Landscapes and Delightful Water Bills.

Atlantic County Parks: The August "Birding with Binoculars Program" event to take place at Estell Manor Park was cancelled due to storm damage. September's birding event is still scheduled for Saturday, September 8th.

GEHWA Overnight Camping and Canoe/Kayak Event: The canoe/kayaking event is scheduled for September 29 and 30, with overnight camping at Camp Acagisca.

NPS Report (Paul Kenney): The Villages of Folsom and Tuckahoe are in the Great Egg Harbor Comprehensive Management Plan. Paul suggested that the RC send a letter to the NPS Regional Director. One of the main points should state what impacts there would be to the water supply by approving new sewer service areas in the Pineland Villages which will enable large scale growth. Rick Coe made a motion to send a letter to the NPS Regional Director. Greg Gregory seconded the motion. It was also suggested that the local governments also send letters. Bill Christman made a motion to send a letter to local governments. Rick Foster seconded the motion. Fred will draft a letter and email it to the RCs. Motion approved.

Old Business:

1. **River Signs:** The contractor who had previously made the river signs has gone out of business. Fred will find a new contractor. Fred displayed a map which indicated 25 potential new locations which would amount to a total of 50 signs that would be located at road crossings. It was suggested that the focus be on local roads initially. The River Councilors will look at the sign locations for their areas, which Fred provided, with the intent of determining the appropriateness of a sign for that road crossing.

River Councilor Reports for each Municipality

Corbin City: (Rick Foster): Corbin City had minor damage from the derecho. Plans are underway to replace the Route 50 Bridge. The current bridge needs constant repairs.

Egg Harbor Twp.: (**David Brown**): The derecho had a big impact of flora and fauna within the watershed.

Estell Manor City: (Jim Owen): The County Park sustained damage from the storm.

GEHWA: (**Dick Colby**): On the 27th of August the Pinelands Commission will be holding a meeting regarding revisions to the Comprehensive Management Plan at the Hamilton Township Town Hall.

Hamilton Twp.: (Bill Christman): Bill sustained major damage to his property from the derecho. The basins at Hamilton Mall are once again being cleaned up.

Hammonton: (Chris Jage): No damage in Hammonton from the storm. September 16th is Hammonton's Green Festival. An inventory is planned of the health trees in the city.

Monroe Twp.: (Rick Coe): No damage in Monroe.

Somers Point: (Greg Gregory): Somers Point cleaned up quickly following the storm.

Upper Twp.: (Bill Handley): Upper Township sustained some damage from the storm, but nothing on the beach was damaged.

Weymouth Twp.: (Bill Egan): Houses along the river had damage from the storm.

Administrator's Report (Fred Akers):

1 Keith Kendrex Resignation: Keith Kendrex submitted a letter of resignation to the River Council on June 20, 2012. Fred suggested purchasing a pair of binoculars as a token of the River Council's esteem for Keith's 9 years of service.
