Folsom: (Joel Spiegel): Joel reported that 8th Street flooded during Hurricane Irene.

GEHWA: (Dick Colby): Dick gave testimony at the Energy Master Plan meeting.

Hamilton Twp.: (Bill Christman): Chiggers are thriving. Hamilton Twp. is awaiting the outcome of Hurricane Irene.

Upper Twp.: (Bill Handley): The channel markers (buoy type) were finally placed on the Tuckahoe River in August.

Alt. Upper Twp.: (Steve Eisenhauer): Steve suggested that GEHWA look into getting bumper stickers. He felt that bumper stickers would provide good exposure for the organization.

Administrator's Report (Fred Akers):

- **1. RC Osprey Project Update:** The Osprey Project received good media attention this year. A data sheet with stats on nests occupied and number of young produced was included in RC's packets
- **2.** Patcong Creek Environmental Steward Volunteer: Holly Horner, Rutgers Environmental Steward Intern will be working on a service project that is centered on and around Patcong Creek. GEHWA will be the host organization for this project.
- **3. NLT Exempt and Tax Delinquent Parcels Project:** Data regarding tax delinquent parcels can be accessed via Google Earth.
- **4. References about Dams and Dam Removal:** American Rivers supports and advocates for the removal of dams. "Natural free flowing rivers are better for the health of a river".
- **5. Folsom Bridge Replacement:** Atlantic County would like to replace the 8th Street Bridge that crosses over Hospitality Branch. The pony trussed bridge qualifies as a historic structure.
- **6.** Herring Rescue Update: There is pressure to list the River Herring as an endangered species. If listed it would force the Fisheries Council to tighten regulations for the protection of these fish.
- **7. River Council Ecology Cruise Program Update:** There are 3 cruises planned for October. RCs can go on the cruises. EHT teacher, Jim Toms may be a candidate for the Pinelands Hall of Fame.
- **8. 2011 River Management Society Fall Outing:** The Great Egg Harbor River will be the focus of River Management Societies Fall Outing. Fred is organizing the event.
