
The Blueback River Herring Lawsuit

Washington, D.C. – The Natural Resources Defense Council (NRDC), Earth Justice, and a coalition of fishing and watershed protection groups including the Great Egg Harbor River Council, the Great Egg Harbor Watershed Association, Anglers Conservation Network, and the Delaware River Shad Fishermen's Association filed a complaint on February 10, 2015 in

federal court seeking to reverse a decision by the National Marine Fisheries Service (NMFS) not to

list the blueback herring as a threatened species under the Endangered Species Act.

Blueback herring once were highly abundant in many coastal waters, rivers and streams of the eastern United States, from Nova Scotia all the way to Florida. In larger rivers, spawning runs could reach well into the millions of individual fish. The movement of enormous schools of silvery, foot-long herring as they left the Atlantic to swim up rivers and streams was an astonishing annual event. A vital part of healthy watersheds and coastal ecosystems, these schools fed predators hungry after a long winter, including striped bass, ospreys, bald eagles, herons, harbor seals, river otters, and people.



But due primarily to the impacts of dams and habitat

destruction, overfishing, and water pollution, blueback herring are now reduced to tiny remnant runs. The commercial fishery has collapsed and a critical food source has gone missing from the ecosystem. The Mid-Atlantic blueback river herring population is particularly imperiled and at risk of extinction.

"The historical abundance of river herring in the Great Egg Harbor River system is long gone. The state of New Jersey has outlawed even the possession of one river herring, but they are still allowed

to be killed in large numbers as bycatch in federal waters. It is time for the National Marine Fisheries Service to list the blueback herring as a threatened species and start to work to bring them back", said Fred Akers, Administrator of the Great Egg Harbor National Scenic and Recreational River Council.

The groups are asking that U.S District Court in DC find the National Marine Fisheries Service in violation of the Endangered Species Act (ESA) and the Administrative Procedure Act (APA), and that the court order the federal agency to prepare a new listing determination within six





Spring is right around the corner! With the warmer weather and flowers blooming soon, what better way to kick-start the season than the annual spring cleanup in the Atlantic County Parks. This program has proved to be successful and a great asset in keeping the Parks green and clean as we enter into the 5th year of the cleanup. To date, roughly 8 miles of roads/trails have been cleaned and approximately 25 cubic yards of trash and 12 cubic yards of recycled material were gathered from various County Park locations. Imagine - that is about 37 washing machines!



This year's event will take place *Saturday April 18th from 8:30 AM until Noon* (rain date April 25, 2015) and will consist of a 2.5 mile roadside area. The cleanup will begin in the Estell Manor Park starting at South River in the North End portion of the Park down Artesian Well Road and continue south along Route 50 to Stephens Creek ending near the Manor House.

The event is cosponsored by the Great Egg Harbor River Council and Great Egg Harbor Watershed Association in partnership with Atlantic County Parks, Friends of the Parks, Atlantic County Utilities Authority and Atlantic County Parks and Environmental Advisory Board.

The Atlantic County Park in Estell Manor provides an essential habitat for trees and wildlife. The Nature Center is also a key feature to the Park as it is a host site for many public meetings and recreation activities. This cleanup not only spruces up the Park's image for spring and summer visitors, but also will help keep the ecosystem clean for all walks of life.

Volunteers are needed to help out with this effort. Please meet in the Nature Center parking lot at 8:15 AM. The cleanup will be broken into 3 teams at roughly ³/₄ mile intervals. Please dress for the weather. Bring gloves and water. Lunch will be provided after the cleanup.
