Education & Outreach Coordinator Report (Lynn Maun)

In Schools, Nature Center, and Outdoor Classroom: Reaching out to teachers regarding programs for Spring 2022.

Marsh Elementary School: Lynn is scheduled to teach the 3rd grade students from Marsh Elementary School at the Fox Nature Center in March.

Williamstown Middle School: Lynn is scheduled to teach the 5th grade students at Williamstown Middle School in April about water quality, stormwater runoff and groundwater.

GEHWA: The Annual GEHWA Member Meeting and program will be held on Tuesday, March 22, 2022 at 6:30. The election of GEHWA Trustees will take place at the meeting. Gregory Gregory will provide the program "Fish Tales with Gregory". The meeting will be hybrid (in person and via Zoom).

ACUA Earth Day Celebration: The 2022 ACUA Earth Day celebration will be held on Sunday, April 24, 2022. We will table at this event.

NPS Report (Paul Kenney): Paul and Fred reviewed the following topics.

- 1. **Dredge Spoils Dumping:** Fred reviewed a proposal to dump dredge spoils from Atlantic City at the Tuckahoe Turf Farms in Estell Manor which is in both the Wild and Scenic River and the Pinelands boundaries. During a 10-year period, 111,217 cu. yds. of dredge spoils will be deposited which amounts to 5,560 truckloads. Fred also reviewed the proposal to dump 1461 cu. yds. or 73 truckloads of dredge spoils at the Surran Soil Replenishment LLC in Corbin City. Fred submitted comments regarding these proposals.
- **2.** Lake Lenape Dam Replacement Plan: Fred reviewed the "Lake Lenape Dam Rehabilitation and Spillway Reconstruction" project to fix the dam.

- 1. Resolution 4-2022 Increase Staff Time for FY 2022: A motion was made by Bill Christman, and seconded by Rick Coe, to approve Resolution 4-2022, to increase staff time for FY 2022. Roll call; all in favor. Motion carried. Julie Akers (Buena Vista Twp.) and Bill Handley (Upper Twp.) abstained. Jen Jennings voted for Buena Vista Twp. and Bill Steumpfig voted for Upper Twp.
- 2. **Resolution 5-2022 Request Increased State Funding for the Pinelands Infrastructure Trust Fund (PITF):** A motion was made by Dick Colby and seconded by Bill Christman, to approve Resolution 6-2022 in support of a request to increase state funding for PITF; with the suggested changes. All in favor. Motion carried.

River Councilor Reports for each Municipality

Buena Vista Twp.: (Julie Akers): Julie informed the RC that municipalities with ORVs issues, can pass an ordinance that enables the confiscation and destruction of an ORV if found to be operating on public lands

Buena Vista Twp.: (Alt. Jenn Jennings): Jenn stated that the weather has not been conducive to the retrieval of ghost pots from the GEHR.

Corbin City: (Carol Foster): Carol announced that the 100-year anniversary of Corbin City will be celebrated on 10-1-2022. They will be selling bricks that will be installed near the garden area at City Hall. She also stated that the ACUA is a source of good information and that they recently provided a program on reusable bags in preparation of the "Plastic Bag Ban" that will go into effect on May 4, 2022.

Egg Harbor Twp.: (David Brown): Dave reported seeing eagles in a tree.

Egg Harbor Twp: (Atl. Tom Baum): Tom reported seeing a seal on the river and an eagle on an osprey platform. He also said that the trees Stockton University is using for its maple syrup project can be seen from Mosquito Landing.

Folsom: (Greg Conway): Greg stated that the water level in Penny Pot Lake is down since the dam broke. He also said that local residents have noticed bald eagles and osprey in area. He wanted to know if an osprey nest could be installed. Greg also said that the Folsom Environmental Commission will be holding their 1st Green Day event on Saturday, April 30, 2022, rain date May 1st., from 10 am – 3 pm., at Cushman Lake in Collings Lakes.

GEHWA: (Dick Colby): Dick announced that Jamie Cromartie, GEHWA Trustee and Stockton professor passed away on 2-15-2022.

Hamilton Twp.: (Bill Christman): Bill has observed 3 juvenile bald eagles fishing in the river at high tide. He is also participating in the review of Hamilton Township's Master Plan, and noted that there is a big change in the Stormwater Management Plans.

Somers Point: (Greg Gregory): Gregory completed a FHWAR survey regarding hunting, fishing and wildlife.

Somers Point: (Alt. Bill Reinert): Bill said that the eagles are incubating eggs at the nest in Somers Point.

Upper Twp.: (Bill Handley): Bill thanked everyone for supporting Brooke.

Upper Twp.: (Alt. Bill Steumpfig): Bill mentioned a tabling event in Cape May on June 11, 2022
